

**Waterford Borough Council
Meeting Minutes – December 7, 2020**

Vice-President Timothy (TJ) LaFlamme called the meeting to order at 7:00pm followed by the Pledge of Allegiance, Invocation.

Public Comment

Minutes

Budget

Judy Cline questioned the pay for the Secretary/Treasurer.

Tim (TJ) LaFlamme motioned to approve the budget for 2021. Garry Sargent seconded the motion. Judy Cline voted no, all others in favor, motion carried.

Tax Ordinance

Tim (TJ) LaFlamme motioned to approve the tax ordinance, raising the taxes to 2.7mils. Joseph Wanson seconded the motion. Beth Weldon voted no, all others in favor, motion carried.

Mayor's Report

Mayor Chad French said he was working on another alley repair with Garry. Chad noted that he has heard many compliments on the Christmas lights.

Public Works

Garry Sargent noted that the guys worked with Cindy Kreider and got the Christmas lights up early. Garry mentioned the recent storm, noting the guys worked some overtime, helping out the cemetery with storm damage and picking up debris from the storm. Garry noted the guys worked a couple Saturdays cleaning up the rest of the leaves. Garry also noted the alley repair is completed.

Parks

Judy Cline mentioned the beautiful Christmas lights and thanked the guys and Cindy Kreider for their hard work. It was noted that Waterford Pizza donated some pizza to the ladies working on the lights and wreaths.

Sidewalks

Tim (TJ) LaFlamme noted that we have \$2,000.00 left in the Sidewalk fund, maybe it can be used for the sidewalk to Tops. TJ also noted that he talked to Gene Price

about possibly repairing the sidewalks. TJ will be meeting with Gene to get more information.

Holly Noble noted that she talked with Scott Driscoll to decide where to put the new sign. Holly also noted that she is going to meet with Michael from Bartlett Signs on Friday. It was noted that the Borough doesn't need a sign permit.

Old Business

Garry Sargent motioned to accept the original fine structure on the South East St. property, eliminate the daily fines and be done with this whole thing and quit wasting taxpayer money. Joe Wanson seconded the motion.

It was decided the motion will be tabled until after Executive Session.

New Business
